# 29. Operation of the WFTU /3

ABSTRACT: Continuation of the statutory norms referring the operation of the WFTU.

#### **PROPOSALS**

The FTE of Mexico presents to the 16th World Trade Union Congress the following proposals:

### OPERATION OF THE WFTU

Secretary of labor and social security

- To make studies on the labor conditions in the diverse sectors.
- b) bTo promote policies, initiatives and actions for the defense of the rights of labor contracts and trade union affiliation.
- c) To promote actions for the gender equity, the rights of youth worker, women and of the immigrants.
- d) To make studies and to promote actions in defense of the social security.
- e) To inform to the International Secretariat about the activities made.
- f) To coordinate the work in these matters with the regional people in charge.

Secretary of Social communication and press

- To make the activities of press and communication of the WFTU.
- b) To be responsible for official publications of the WFTU.
- c) To promote the communication between the affiliated and fraternal organizations of the WFTU.
- d) To inform to the Inter Secretariat the International into the made activities.
- e) To coordinate the work in these matters with the regional people in charge.

Secretary of international relations

- a) To exert the international relations of the WFTU.
- To maintain a near communication with all the affiliated organizations and fraternal of the WFTU.
- c) To maintain shared in common relations with the union organizations of the world.
- d) To inform to the Secretariat the International into the activities done.
- e) To coordinate the work in these matters with the regional people in charge.

## 2011, elektron 11 (29) 2, FTE of Mexico

Article 44 - According to the nature of their functions, the diverse secretaries will represent the WFTU before the respective international organisms.

Article45 - The structuring of the regional spaces will become according to the structure of the World Trade Union Congress, the Executive Council and the Secretariat of the WFTU.

## VIII.5 - The regional secretary

Article 46 – The obligations and functions of the Regional Secretaries will be the following ones:

- To represent by implicit delegation the WFTU in the subjects that corresponds specifically to the region.
- b) To cause and to coordinate the development of the activities of the WFTU in the region, decided by the regional Congresses, Conferences or plenary sessions of the Executive Council
- c) To impel the organized activities, of unit and solidarity between the affiliated ones in the region.
- d) To promote the communication, information and solidarity between the affiliated ones of the region.
- e) To inform, and to coordinate with the General Secretariat and of Organization, the activities in its respective regions.
- f) To inform to the Secretariat of the WFTU of the activities in which him (her) participates.

#### VIII.6 - Commissions

Article 47- Commissions of the WFTU are created with objectives and specific

functions and they are of permanent character.

Article 48-La Commission of Financial Control is formed by a President and two Secretaries.

Article 49- The Technical Commission depends on the Secretariat of Organization, this last one in agreement with the General Secretariat, will propose its integration considering, specially, the collaborations. Its location is in the headquarters of the WFTU.

Article 50 -The attributions and functions of the Commissions are the following ones:

The commission of financial control

- a) To watch the correct performance of the Secretariat of Finances.
- b) To control the economic and financial handling of the WFTU
- c) To approve, in first instance, the periodic reports of finances.
- d) To inform about its activities to the Executive Council and the World-wide Union Congress.

The technical commission

- a) To make studies supporting the WFTU in the diverse aspects and sectors.
- b) To participate in the activities of press, propaganda and publications.
- To conserve the historical file and the documentation of the WFTU.
- d) To foment and to make specific the collaborations of affiliated and the friends of the WFTU.
